## CONTRIBUTING AUTHORS & SPEAKERS

**DONNA SUZANNE BARGO** has, for the past 15 years, been an Administrative Hearing Officer with the Cabinet for Families and Children in Kentucky. Judge Bargo's docket consists mainly of appeals of findings in child abuse/neglect investigations. Prior to becoming an AHO, Judge Bargo conducted this type investigation as a MA level Social Worker for the same Cabinet. Judge Bargo received both her undergraduate and graduate degrees from Eastern KY University. She has completed the Administrative Law program presented by the National Judicial College and has been awarded Hearing Official Certification by the National Association of Hearing Officials. In her second term as member of the NAALJ Board of Governors, Judge Bargo is Chairperson for the Non-Attorney ALJ Committee and is Co-chair, with Judge Janet Thompson, of the 2002 National Conference. In addition, Judge Bargo is a charter member and the President Elect of NAALJ's KY affiliate, the KY Association of Administrative Adjudicators.

**PHYLLIS E. BERNARD** is Professor of Law and Director of the Center on Alternative Dispute Resolution at the Oklahoma City University School of Law. Professor Bernard received her A.B. degree from Bryn Mawr College; her M.A. from Columbia University; and her J.D. degree from the University of Pennsylvania. She has served as a consultant to the Administrative Conference of the United States in developing an ADR process to replace most Medicare adjudications for institutional providers. As a state commissioner serving on the Oklahoma Merit Protection Commission, she helped develop rules and procedures replacing much of the state merit system appeals process with ADR, and helped develop the first ethics rules for Merit Protection commissioners. She has served as a consultant to the U.N. World Health Organization, advising the Lao People's Democratic Republic on privatization of their health care system and development of a quality of care dispute resolution system. Professor Bernard has started a pro bono consultation with the International Federation of Women Lawyers in the Niger Delta, where she was asked to design an appropriate tribal peacemaking program. She is widely published and a frequent lecturer on alternative dispute resolution.

**ANN BREEN-GRECO** is an Administrative Law Judge with the Illinois State Board of Education, presiding over special education hearings. Previously, she was an Administrative Law Judge at the Illinois Department of Children and Family Services, presiding over child welfare hearings, including abuse and neglect, licensing, and service appeal cases. She is an arbitrator with the Federal Mediation and Conciliation Service, U.S. Postal Service, and Illinois Cook County Mandatory Court-Annexed Arbitration. She is also a mediator with the Illinois Department of Human Services, mediating vocational rehabilitation and early intervention cases and for many years was a mediator with the Center for Conflict Resolution. Judge Breen-Greco has also chaired a number of panels as a hearing officer with the U.S. Track and Field Doping Review Board. Judge Breen-Greco is on the board of the National Association of Administrative Law Judges and President of the Illinois affiliate. She is a regular faculty member for annual conferences for administrative law judges, conducting a number of workshops on professional development for administrative law judges. She has also served as adjunct faculty of Cornell University School of Industrial Labor Relations' Mediation Training Program. Judge Breen-Greco was the co-editor of the NAALJ newsletter for a number of years and also continues to serve as Chair of Publications and Editor of the newsletter for the American Bar Association

National Conference of Administrative Law Judges. A long-time political and social activist, she is co-chair of the Legislative Committee of the Women's Bar Association of Illinois (WBAI). She is also a recipient of the U.S. Customs Department Woman of Vision and Courage award; Illinois Institute of Technology Women's Network Julia Beveridge award; Illinois Treasurer's Woman to Woman award—Women Making a Difference, motivational category;. Judge Breen-Greco has led stress reduction sessions for judges, community groups, day-care providers, students, and individuals. She has written a book titled, *Women In Control: A Guide To Creating Your Own Fitness Lifestyle For Body, Mind, And Spirit*, recently published by iUniverse.com.

**A. B. "BEN" CHANDLER** was first elected Attorney General of Kentucky in 1995. Having built a strong record of fighting against government corruption, he was reelected without opposition to a second term in 1999. He previously served a four-year term as Kentucky State Auditor. As Attorney General, he has been an independent public servant representing and protecting the citizens of the Commonwealth. For example, on behalf of the people of Kentucky, he filed a lawsuit against the Anthem Insurance Company of Indiana and recovered \$45 million in charitable assets once belonging to the former Kentucky Blue Cross Blue Shield Insurance Company. He has also worked hard to protect consumers, seniors, victims of violent crime and all citizens by successfully fighting against public corruption, financial identity theft, telemarketing fraud, prescription drug trafficking and nursing home abuse. He also won passage of legislation that requires violent offenders to serve at least 85% of their prison sentences, and increases the amount of restitution that all criminals must pay to the victims of their crimes. Ben Chandler and his wife, Jennifer, have three children -- Lucie, Albert IV, and Branham. The Chandlers live in Woodford County, Kentucky and are members of the Pisgah Presbyterian Church.

**SAMMIE CHESS JR.** has been an Administrative Law Judge with the North Carolina Office of Administrative Hearings since 1991. He graduated from North Carolina College at Durham (now North Carolina Central University) receiving his B.A. in 1956 and his law degree in 1958. From 1960 to 1971 he was a trial lawyer, participating in numerous civil rights cases involving sit-ins, demonstrations, equal employment, picketing, school desegregation and hospitals, among others. He was a cooperating attorney with the NAACP Legal Defense Fund in the case of *Griggs v. Duke Power*, 401 U.S. 424 (1971). From 1971 to 1975, he was Judge of the Superior Court in North Carolina, the first African-American to be appointed to the Superior Court in North Carolina. From 1975 through 1991, he practiced law in High Point, North Carolina, and is a past President of the High Point Bar Association. He is a former member of the Board of Trustees of Winston-Salem State University and of the North Carolina Board of Higher Education, and has been a member of the NAALJ Board of Governors since 1995.

**JUDGE JENNIFER B. COFFMAN**, a United States District Judge for the Eastern and Western Districts of Kentucky. She was appointed to the federal bench by President Clinton in 1993. Before her appointment she was a trial lawyer in private practice and a legal writing instructor at the University of Kentucky College of Law, from which she graduated in 1978. She also holds a Bachelor of Arts in English and a Master of Science in Library Science from the University of

Kentucky. Judge Coffman's publications include two student publications in the Kentucky Law Journal and a chapter of Employment Law (University of Kentucky College of Law, Office of Continuing Legal Education 1992). She frequently speaks at law-related conventions and seminars. Her professional activities include chairing the Kentucky Bar Association Convention, serving on the Fayette County, Kentucky, Bar Association Board of Governors, and serving the UK College of Law as President of its Alumni Association and as a member of its Visiting Committee and twice on its Dean Search Committee. She was awarded the Kentucky Bar Center Award by the Kentucky Bar Association in 1993 and she was a charter member of the UK College of Law Alumni Hall of Fame. Judge Coffman serves on the Judicial Resources Committee of the Judicial Conference and on the Sixth Circuit Pattern Jury Instruction Committee. Her civic activities include Board of Directors service for both the YWCA of Lexington, Kentucky, and Shepherd Center Rehabilitation Hospital Board in Atlanta, Georgia, as well as service in various capacities at her church. She received the YWCA Woman of Achievement Award in 1994 and in 2001 she received the Equipoise Award, for maintaining a family-life balance, from the Lexington, Kentucky chapter of National Association of Women Business Owners.

**ALLISON CONNELLY** joined the faculty of the College of Law as an Assistant Professor in 1996 and as the first Director for the UK College of Law Legal Clinic. Prior to joining the law school she spent 13 years as a state public defender. She rose through the ranks to become the first female Kentucky Public Advocate, the head of Kentucky's statewide public defender system, and has several published appellate decisions to her credit. She received her B.A. degree from the University of Kentucky and was awarded her J.D. degree from the University of Kentucky College of Law. Prior to joining the faculty, she served as an adjunct professor with UK beginning in 1986 teaching in legal writing, litigation skills, criminal procedure, and criminal trial process. She has lectured locally and nationally on criminal justice issues, and serves as a member of UK's Council for the Aging.

**LARRY CRADDOCK** has been very active with NAALJ (board member, 1995-1997, treasurer, 1998-2000, president-elect, 2000-2001, president 2001-2002). Judge Craddock was also the first president of the Texas Chapter of NAALJ, the Texas Association of Professional Administrative Adjudicators (TAPAA), 1999-2000. He was also a chair of the 2001 NAALJ Annual Convention and Training Conference in Austin, Texas. In the past, Judge Craddock has also been a chair of the NAALJ Membership and State Affiliates Committee, and the NAALJ Budget Committee. Judge Craddock has been an administrative law judge with the Texas Department of Banking since 1992 and an administrative law judge with the Texas Finance Commission agencies (the Department of Banking, the Savings and Loan Department, and the Office of Consumer Credit Commissioner) since 1995. Before becoming an ALJ, Judge Craddock was at various points in his career an Assistant Attorney General of Texas, an Assistant General Counsel to the Governor of Texas, the General Counsel to the Texas Comptroller of Public Accounts, and Special Counsel to the Texas Public Utility Commission.

**STANLEY J. CYGAN** is Manager of the Office of Administrative Hearings-Tax, Illinois Department of Employment Security. He received his B. A. from the University of Illinois at Chicago in 1971 and was awarded his J. D. from Loyola University School of Law, Chicago in 1974. He is also an Alumnus of the National Judicial College, Reno. Mr. Cygan is Director at

Large, Government Bar Association (GBA) (1994-1996); Chair, GBA Chicago Program and Activities (1994-1996); President, National Association of Administrative Law Judges (NAALJ) (1991-1992); Secretary, NAALJ (1979-1985); Board of Governors NAALJ (1979-1996); President, Illinois Association of Administrative Law Judges (IAALJ) (1979-83); Treasurer, IAALJ (1999-Present); Director, IAALJ (1978-Present); Editor, The IAALJ, newsletter of the IAALJ (1996-Present); Member, NAALJ, IAALJ, GBA, American Bar Association (ABA), Chicago Bar Association (CBA), and National Conference of Administrative Law Judges; Chair, CBA Administrative Law Committee (1982-1983, 2001-2002); Chair, CBA Administrative Law Judges Committee (1997-1998). Recipient CBA David C. Hilliard Award (1977); Chair, Co-chair, NAALJ Ethics Committee (1992-1995); Chair, NAALJ Audit Committee (1996-Present); and Director, NAALJ Survey of Administrative Law Judge Salaries (1996-Present). He has served as the Managing Editor for the Journal of the National Association of Administrative Law Judges (J.NAALJ) from 1983-present. Mr. Cygan is the Author of Adjudicative Procedure and the Model State Administrative Procedure Act (1981), 3 J.NAALJ 27 (1983) and Development of the Model Code of Judicial Conduct for State Administrative Law Judges, 14 J.NAALJ 269 (1994). Prior to her current position, Lori practiced civil rights law with the Kentucky Department of Public Advocacy. In this position for over four years, Lori represented many Kentuckians with disabilities in asserting their legal rights. As a member of the ABA, she serves as the Young Lawyers' Division Liaison to the Administrative and Regulatory Practice Section and as a judge with the Young Lawyers' Division Awards of Achievement program. **THOMAS E. DEWBERRY** is the Chief Administrative Law Judge of the Maryland Office of Administrative Hearings, appointed by Governor Parris N. Glendening, and effective May 22, 2002. A 1977 graduate of Baltimore Law School, he served as Hearing Examiner and Senior Hearing Examiner for the Maryland Public Service Commission beginning in 1979. He is a member of the American Bar Association; the Maryland State Bar Association; the Baltimore County Bar Association; and the State and National Association of Administrative Law Judges. Mr. Dewberry is active in numerous professional and civic organizations.

**WILLIAM F. DRESSEL** became the President of The National Judicial College in November 2000. He obtained his B.A. from Cornell College, Mt. Vernon, Iowa, and his J.D. from University of Denver Law School. From 1966-1978 he was in private practice, in both Denver and Fort Collins, Colorado, specializing in trial practice. In July 1978 he was appointed as a judge to the 8th Judicial District, State of Colorado, and retained in 1980, 1986, 1992 and 1998 general elections. Judge Dressel was licensed to practice law in the State of Colorado in April

1966 and has been admitted to practice before the Supreme Court of the State of Colorado, 10th Circuit, and the U.S. Supreme Court. Judge Dressel has been president of the Colorado District Judges' Association and chair of the Colorado Trial Judges' Council, which represents both district and county judges in the State of Colorado. From August 1992 to August 1993, Judge Dressel was chair of the National Conference of State Trial Judges, and from 1987-1993 was chair of the Court Delay Reduction Committee of the National Conference of State Trial Judges. In 1991 Judge Dressel was appointed by Colorado Chief Justice Rovira to be the Judicial Department's representative on the Colorado Legislature's Criminal Justice Commission, and was reappointed for a second term in 1993. Ms. Durant received her training as a mediator in 1993 and was certified in 1995 by the Mediation Center of Kentucky. The Division offers mediation services for over sixty boards and agencies. Predominantly the disputes mediated concern professional disciplinary actions. Ms. Durant is the co-author of Kentucky Administrative Law, UK/CLE Practice Handbook, 1999; "Procedural Due Process Past Due: Kentucky's Uniform Administrative Hearing Procedures Act Goes into Effect," Kentucky Bench & Bar. **WILLIAM H. FORTUNE** is a Professor with the University of Kentucky College of Law where he has been a member of the faculty since 1969. Prior to joining the law faculty and on several occasions since, he has been actively engaged in the practice of law. He has

**JOHN W. HARDWICKE** was appointed the first Chief Administrative Law Judge of the Maryland Office of Administrative Hearings in 1989 by Governor William Donald Schaefer and reappointed in 1996 by Governor Parris N. Glendening for a six year term. He retired from that position in June 2002. Hardwicke received his A.B. Degree from the University of North Carolina--Chapel Hill in 1950 and his LL.B Degree from George Washington University, in 1953. From 1953-1955 he was Assistant Counsel, to the Controller of the Currency, Washington, D.C. Since 1955, he served as Instructor in Commercial Law, Evening School, Hopkins University, Baltimore, Maryland. From 1955-1957, he was an Associate, with Piper and Marbury, Baltimore, Maryland. He was an elected member of the Maryland House of Delegates from 1963-1967 and chaired the House Judiciary Subcommittee on the Uniform Commercial Code. He was an elected member of the Maryland State Constitutional Convention from 1967-1968. In 1969, Hardwicke served as one of the organizers of the Florida Phosphate Council, Tampa, Florida, broad-based consortium of phosphate miners, state and federal environmental, tax and mining problems and from 1972-1990 he served as Counsel to the Maryland Industrial Group, a broad-based consortium of Maryland industry established to deal with natural gas, electricity, energy curtailments and related problems as well as taxation and environmental matters. He was elected Councilman at Large, Harford County, Maryland, Council from 1972-1974 and elected President, Harford County, Maryland Council 1978-1990. In 1987, Hardwicke co-authored, with Robert W. Emerson, Business Law, a textbook published nationally and internationally by Barron's Educational Series, Inc. In 1992 he was a member of the Maryland Commission to Revise the Administrative Procedure Act. He is a past President (1996) of the National Association of Administrative Law Judges and chair-elect of the National Conference of Administrative Law Judges (2001-2002). He is a member of the Maryland Bar Association, the American Bar Association and the Bar of the United States Supreme Court.

**MICHAEL P. HEALY** is the Dorothy Salmon Professor of Law at the University of Kentucky College of Law. He teaches in the areas of environmental law, torts, and administrative law. Mike received his undergraduate degree from Williams College and his law degree from the University of Pennsylvania where he was articles editor of the University of Pennsylvania Law Review. Mike came to the law school in 1990. Prior to entering teaching he served as an attorney with the Environment and Natural Resources Division of the U.S. Department of Justice and as a law clerk for Judge Edward R. Becker of the U. S. Court of Appeals for the Third Circuit.

**JOSEPH M. HOOD** is United States District Court Judge for the Eastern District of Kentucky, Lexington, Kentucky. Judge Hood was nominated for appointment Jan. 24, 1990 by President Bush; confirmed by the Senate on April 27th 1990. Judge Hood's education background is as follows: University of Kentucky, Lexington, 1960-65, B.S. in commerce, 1965-1966, graduate studies, Dept. of Economics, graduate teaching asst.; University of Kentucky College of Law, Lexington, 1970-72, J.D. He entered active duty, U.S. Army in 1966 and was released as CPT in 1970 after service as infantry commander in Vietnam, 1968-69. He served as Law Clerk to Judge H. David Hermansdorfer, U.S. District Court for the Eastern District of Kentucky, Catlettsburg; 1976-1990, and as Magistrate Judge, U.S. District Court Eastern District of Kentucky, Ashland and Catlettsburg. He was admitted to KY Supreme Court and U.S. District Court for the Eastern District of KY, 1973. Judge Hood received the Kentucky Bar Association Outstanding Judge Award in 1999. His military awards and decorations include the Bronze Star with "V" Device and four oak leaf clusters, Air Medal, Army Commendation Medal with "V" Device and one oak leaf cluster and the Purple Heart. He is a member of the KY, and Fayette County Bar Associations; Lambda Chi Alpha; Phi Delta Phi; University of Kentucky Alumni Association; Federal Judges Association; and the Judicial Conference of the United States Committee on Financial Disclosure.

**JAMES F. HORAN** has served as an Administrative Law Judge at the New York State Department of Health since 1991. Previously, he served as a Senior Attorney with the Health Department's Bureau of House Counsel and on temporary assignment at the Bureau of Legislation. He also conducts hearings by designation for the New York State Department of Economic Development and the State Consumer Protection Board. Upon graduation from law school, he served as Law Assistant to Fulton County Judge and Surrogate Robert P. Best. Judge Horan graduated from the University of Notre Dame and from Albany Law School and he has completed various courses in adjudication at the National Judicial College. He serves as a panel member for the Surrogate Decision-Making Program of the New York State Commission on the Quality of Care for the Mentally Disabled. He served as the President of the New York State Association of Administrative Law Judges (2001-2002) and was Program Chair for the National Association of Administrative Law Judges' National Conference and Seminars in Albany, NY in October 2000. After graduating from law school, he was appointed Assistant District Counsel for the U. S. Army Corps of Engineers' office in Wilmington, North Carolina. He subsequently served for five years as an Assistant United States Attorney for the Eastern District of North

In 1979 he entered private law practice in Duluth, Minnesota, specializing in admiralty law. **JAMES E. KELLER** is a Justice on the Kentucky Supreme Court, where he has served since May of 1999. Prior to his service with the Supreme Court, Justice Keller served as Fayette Circuit Court Judge beginning in 1976. Prior to his service on the bench, Justice Keller spent ten years engaged in private practice and served as Master Commissioner for the Fayette Circuit Court from 1969-1976. He attended Eastern Kentucky University for his undergraduate education and later graduated from the University of Kentucky College of Law. Judge Keller is well known for his extensive work with and dedication to the legal professional. He has lectured and written widely. His treatise written with UK law professor Louise Graham, Kentucky Family Law, is well known, and used by family law practitioners on a daily basis.

**MARVIN F. KITTRELL** ("Buddy") is Chief Administrative Law Judge for South Carolina. Mr. Kittrell graduated (cum laude) from Furman University, was awarded his J.D. degree from the University of South Carolina, and earned his LLM (taxation) from the University of Florida. He is Past President of the Newberry County Bar Association; Past President of the Rotary Club of Newberry; and a Board Member and Past President of the National Association of Administrative Law Judges. Mr. Kittrell is Past President of the National Association of Central Panel Directors and Chief Administrative Law Judges and served on the National Judicial College in 1993, 1995 and 1999. He was engaged in the private practice of law with Dennis and Dennis from 1971-1973; Griffith and Kittrell, 1977-1990; served as a Commissioner with the S.C. **RAYMOND A. LIMON** received his B.A. in Political Science from the University of Nevada-Reno and his J.D. from Indiana University in Bloomington. **SHEILA C. LOWTHER** is Chief Administrative Law Judge for the Kentucky Department of Workers Claims. She graduated cum laude from Transylvania University in 1977. Judge Lowther was in private practice in Madisonville, Kentucky, from 1980 through April 1995. **JULIAN MANN, III** has been Chief Administrative Law Judge and Director of North Carolina's Office of Administrative Hearings since 1989. **DAVID MARCUS** is an Administrative Law Judge, Arbitrator and Facilitator with the Oregon Hearing Officer Panel in Salem, Oregon. His area of concentration is construction contract disputes and contractor licensing and disciplinary cases referred to the Panel by the Oregon Construction Contractors Board. Mr. Marcus formerly served as an Administrative Law Judge for the Oregon Department of Transportation and has also served in several capacities in the Department of Human Resources. **TIMOTHY E. MOORE** is a veteran West Group Government Account Manager. Tim has taught Westlaw research across the country over the last twelve years. He served in the military for ten years, and left the U.S. Army as a Captain. Tim currently serves as an elected, voting member of the Sangamon County Board in Springfield, Illinois. **DENNIS J. MOSS** received a Juris Doctor with Honors from the University of Texas at Austin in 1982. He began his legal career as an associate with the Washington, D.C. office of Baker & Botts where he represented major national and international energy corporations in complex litigation matters before state and federal courts and before various federal agencies. **MARY C. NOBLE** obtained a bachelor's degree in English from Austin Peay State University in 1971 and a master's degree in psychology in 1975. She attended law school at the University of Kentucky in Lexington, and received her J.D. in December, 1981. She was elected to the bench in 1992, and has served two terms as Chief Judge of the Fayette Circuit Court. Judge Noble has been a speaker on a variety of legal topics, and has served as Chair of the statewide Gender Fairness in the Courts Committee, the Juvenile Justice Advisory Board, and the Attorney

General's Task Force on Prescription Drug Abuse. She presently serves on the State Civil Rules Committee, the AOC Drug Court Advisory Committee, and is Secretary-Treasurer of the Circuit Judges Association of Kentucky. She is on the Board of Chrysalis House, a residential treatment facility for women, and conducts Drug Court. As a practitioner, Judge Noble was a litigation attorney, practicing in the areas of school law, personal injury and criminal law. She has done both defense and plaintiff representation. Prior to her election as circuit judge in 1992, she served as Domestic Relations Commissioner for Third Division, Fayette Circuit Court.

**LOIS F. OAKLEY** is the Chief State Administrative Law Judge for the central panel in Georgia. Prior to her appointment to this position in 2000, Judge Oakley practiced corporate law with a major Southeastern law firm, served as an Assistant Attorney General for the State of Georgia, engaged in the legal search business, and served as the Academic Director of a post-graduate paralegal program. Judge Oakley is a graduate of Wellesley College and the Georgetown University Law Center.

**GREGORY L. OGDEN** is a professor of law at Pepperdine University where he has taught since 1978. He teaches administrative law, civil procedure, professional responsibility, and remedies. He is a graduate of UCLA, (BA, cum laude) UC Davis school of Law (JD, Law Review Editor), and he has two LLM's, one from Temple University in legal education, and one from Columbia University in administrative law. Professor Ogden is the faculty editor of the Journal of the NAALJ. Professor Ogden has spoken at several recent NAALJ conferences on current developments in administrative law, and judicial ethics for ALJ's. He was on the planning committee for the Evidence for ALJ's program hosted at Pepperdine Law School in May, 2001. **GOVERNOR PAUL PATTON** is the Commonwealth of Kentucky's 59th governor having been first elected in 1995 and winning reelection for a second term in 1999. Paul Patton is unabashed when he pays tribute to the role his family and his home near Louisa have played in his life and career. He is proud of his heritage and says there aren't many places on earth that can leave an impact on one's values like Eastern Kentucky. "I know of no place with greater extremes - physical and human - or greater pride and strength." Governor Patton graduated from Louisa High School in 1955. Because his father, a teacher, knew first hand the value of education and saved every month for his son's education, Paul attended the University of Kentucky. It was there that he began preparing for his successful career in business and

government, graduating in 1959 with a degree in mechanical engineering. He then worked as a laborer in a coal mine in McDowell in Floyd County where he learned everything he could about the coal business. That determination led to establishing his own coal company which he ran for twenty years, until 1979. He then looked to public service, joining the administration of John Y. Brown Jr. in 1979 as deputy transportation secretary. During this time he also served as chairman of the Democratic Party of Kentucky. He ran for office himself in 1981 and won the race for Pike County Judge-Executive. In 1991, Paul Patton won his first statewide race for the office of Lieutenant Governor of the Commonwealth of Kentucky and became the first person elected to that office to also head a state cabinet. In his capacity as Secretary of the Cabinet for Economic Development, Patton continued his work to bring jobs to Kentucky. Economic development legislation Governor Patton wrote and helped pass in 1992 was modeled on his 1987 proposal to provide incentive programs to counties with consistently high unemployment rates. These programs have been credited with creating thousands of jobs across Kentucky.

**EDWIN S. SEGAL** is Professor of Anthropology at the University of Louisville. At the University Professor Segal is a member of the President's Commission on Diversity and Racial Equality, the University Diversity Committee, the Multicultural Center Advisory Board, and the Women's Center Advisory Board. Some of his courses are cross-listed with, and counted as part of the curricula of the Pan African Studies Department, Women's Studies Program and the Program of Studies in Religion. He has been a participant in diversity workshops sponsored by the Association of American Colleges and Universities, the Kentucky Council on Postsecondary Education, Indiana University and the National Institute for Leadership Development. He has spoken about diversity in a variety of venues, including the Louisville Science Center, and the Louisville Jewish Community Center. Professor Segal's research interests focus is on the intersections of ethnicity and gender in the context of developing nations. He has also written about teaching and curricular reform.. He has focused his research on Africa and has done field work in Nigeria, Cameroon, Kenya, Tanzania, Malawi, and South Africa. However, his most recent field experience was in Kyrgyzstan, in central Asia. He was a participant in an exchange program funded by the U.S. State Department and given to Indiana University and the Indiana Consortium for International Programs. The program is located at the American University in Kyrgyzstan. While there, he taught two classes for undergraduates, conducted a Faculty Seminar and participated in a variety of curricular and administrative consulting activities. These were all part of the university's effort to create an educational institution modeled along the lines of a U.S. university. Unfortunately, as a result of the events of September 11, most U.S. citizens working in Kyrgyzstan were asked, by the U.S. State Department, to leave at the end of September.

**ANN M. SHEADEL** graduated magna cum laude from Wittenberg University in 1970 and magna cum laude from Wayne State University Law School in 1978. She has practiced law since 1978 in a variety of public service and governmental organizations, as well as in private practice, including the Upper Peninsula Legal Services, the U. S. Department of Justice, the Rhode Island Attorney General's Office, Wyatt, Tarrant & Combs law firm, and the University of Louisville. Currently, Ms. Sheadel works in the Kentucky Attorney General's Office, where she is serving as the Director of the Division of Administrative Hearings. She also has served that Office as the Director of the Consumer Protection Division, the Director of the Civil and Environmental Law Division, and the Assistant Deputy Attorney General.

**HENRY L. STEPHENS, JR.** is Professor of Law and former Dean at the Chase College of Law at Northern Kentucky University where he teaches courses, lectures and produces scholarship in the areas of Alternative Dispute Resolution, Evidence, Environmental Law, Administrative Law, Trial Practice and Mining Law.
